DISTRICT ATTORNEY KATZ HOSTS 8TH ANNUAL MOCK TRIAL COMPETITION

15 Top-Tier Law Schools from Across US Participate; Rutgers School of Law Wins First Place

The Queens District Attorney's Office hosted its 8th Annual Mock Trial Competition over the weekend, with Rutgers School of Law defeating 15 other teams from top-tier, nationally ranked law schools. New York Supreme and Criminal Court judges presided as law school students competed before senior prosecutors and members of the defense bar. The event was in-person for the first time since the Covid-19 outbreak in 2020.

District Attorney Katz said: "I am impressed with the exceptional performances of the teams in this year's mock trial competition and excited that we could convene in-person for the first time in four years. For their service and mentorship to the participants, I want to thank my colleagues in the judiciary and defense bar, as well as the prosecutors from my office who made this a tremendous learning experience for these students. Our legal system depends on cultivating new professionals with the high level of dedication, preparation, and performance they all demonstrated this weekend."

Rutgers University School of Law won the competition, defeating 15 other national teams. The champion team of four women was comprised of Livie Ruhl, Elizabeth Weinman, Paula Echeverria and Melanie Zelikovsky. The second-place winners were participants from the Drexel University, Thomas R. Kline School of Law. Winner of Best Oral Advocate, Final Round was Peter Gaynor of Drexel University Thomas R. Kline School of Law.

During the mock trial tournament, each team of second-year law students studied a fact pattern and prepared a mock trial from the competition which began on Friday evening March 3. The competition consisted of two preliminary rounds, quarterfinals, semi-finals and a final round. Judges from Queens and Brooklyn counties volunteered to preside, along with seasoned prosecutors and defense attorneys who acted as evaluators and bailiffs. Participants received feedback each round and a culminating score from evaluators.
